RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY, AND PARENTAL CONSENT AGREEMENT ("Agreement") for SoccerKnocker Wisconsin LLC

IN CONSIDERATION of being permitted to participate in any way in (SoccerKnockerwi) (Club) Sponsored SoccerKnockerwi activities ("Activity") I, for myself , my personal representatives, assigns, heirs, and next of kin ;

1.) **ACKNOWLEDGE**, agree represent that i understand the nature of soccerknockerwi activities and that i am qualified, in good health, and in proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted in both public and private parks and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2.) **FULLY UNDERSTAND** that (a) SoccerKnockerwi Activities **INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY , PARALYSIS AND DEATH ("RISK")**; (b) these risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activity, the conditions in which the activity takes place, or **THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW** ; (c) there may be **OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES** either not known to me or not readily foreseeable at this time; and I **FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COST AND DAMAGES** I may incur as a result of my participation in the activity.

3.) **HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE** the club, the SoccerKnockerwi LLC, its respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which activity takes place, (each considered one of the "RELEASEES" herein) **FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGE ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS**, And, I **FURTHER AGREE** that if, despite this **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT** I, or anyone on my behalf, makes a claim against any of the releases, I **WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES** from and litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such a claim.

4.) **AGREE** to not participate in the activity if i am physically or mentally unable, and that I am responsible for making that determination. I will abide by any decision made by a representative of the club relative to my safety and the safety of others and agree that lack of decision does not create a liability. Pets are not allowed to accompany participants or participate in the Activity.

5.) **GRANT PERMISSION** to the club, representatives of the Soccerknockerwi, its affiliates and sponsors to use any photographs, motion pictures or anything recorded at the activity for purposes

including, but not limited to promotion advertising and marketing, All Photographs, motion pictures or anything recorded at the activity are sole property of Soccerknockerwi, LLC

I AM 18 YEARS OF AGE OR OLDER, HAVE READ AND UNDERSTAND THE TERMS OF THIS AGREEMENT, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT, HAVE SIGNED IT VOLUNTARILY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST ALLOWED BY LAW, I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
