Business Meeting Minutes
October 14, 2025**

1. Meeting called to order by **Chief Craig Olson** at 7:20 PM.
2. Notice confirmed as posted at the Village Hall and on the Department website.
3. Members recited the Pledge of Allegiance
4. Moment of silence for fallen firefighters.
5. Roll Call 36 members present, 35 members absent
6. A motion was made by Vicki Boegel to approve the September 2025 minutes as posted; second by Perry Wahnschagge. Motion carried (voice vote).
7. Bills were read by **Justin John** Motion to approve the bills by **Jeff Lindsey**; second by **Don Schrauth**. Motion carried (voice vote).
8. Treasurer's Report: Financial statement arrived late; to avoid a negative fire account balance (driven largely by ~\$50,000 concrete expense), a motion was made to transfer **\$75,000** from EMS funds to the fire account. Motion by **Don Stoffel**, second by **Vicki Boegel** Motion carried (voice vote).
9. Drills:
Fire Practice – **October 21, 6:00 PM**
Fire Practice – **October 28, 6:00 PM**
EMS Practice – **November 4, 6:00 PM**
10. Next Business Meeting: **November 11, 7:00 PM** (following Association meeting).
11. Membership:
Logan Hargis recommended for full membership (completed one-year probation; Firefighter I coursework noted). Ballots distributed; result **17 yes, 0 no**. Motion to destroy ballots by **Don Schrauth**; second by **Tony Stoffel**. Motion carried.
Personnel changes: Max Monte separated; Willie Dorch and Kelly Schrauth moved to Associate status; **Jackie Botsler** accepted a full-time position (moved from part-time).
Hiring: Two additional full-time positions to be filled; **nominations for Chief** due by or at the next meeting.
12. EMS meeting held last Monday; moving toward staffing model with one AEMT on duty 24/7/365. Members placed on a “night of the week” rotation; members are responsible for arranging coverage within crew, then outside as needed.
Weekends: Returning to **five-weekend rotation** starting **Nov 1**.
New Ambulance Update: Detailing in progress; radio installed; decals pending (quotes from North Central and Westfall). Stryker to swap auto-loader from 401 into new unit; state inspection required prior to service. Estimated in-service mid-November (subject to completion).
13. Training Committee: Next week—hydrant connections and pumping (practice at station hydrant, then in the field).
14. Communications:DNR grant: Not selected this cycle for pagers/radios.
Phone-to-radio app demo: Enables talk on Fire/EMS channels via phone with talkgroups; early use was positive. Cost: **\$3,000** first channel; **\$1,500** each additional; exploring county-wide participation to reduce per-dept cost. Positive references from Dodge County/Iron Ridge.

Mark your calendars: **Jan 21** – Chief David Briggs “Main Street Strategy & Tactics” class in Fond du Lac (venue TBA); seeking county chiefs’ cost share (~\$800).
